Ganihar amounts not to maintaining absolute integrity, devotion to duty and as she has done the acts which are unbecoming of an employee of University.</p> <p>Further, it was resolved to constitute One Man Inquiry Committee headed by a retired judge to hold the inquiry about misconduct of Dr. (Smt) N. N. Ganihar. The Inquiry Officer is requested to submit the report within 30 days.</p> <p>Further, it was also resolved to authorize the Vice-Chancellor to appoint Inquiry Officer in consultation with the Legal Advisor of the University and to frame the Articles of Charges. It was also resolved to issue a Circular to all the PG Departments, Constituent Colleges and Affiliated Colleges stating that the Research Guides should not give scope for unwarranted incidents warranting suspension or any other course of action during the period of their guidance to the Ph.D / M.Phil candidates so as to maintain absolute integrity, devotion to duty and do nothing which is unbecoming of an employee of the University as stipulated under Section 3 of the Karnataka University Employees Service (Conduct) Rules-1993.</p>
