Guidelines for Committee

In pursuance to the directions of the Hon'ble Supreme Court dated 08.05.2009 in Civil Appeal No. 887/2009 and the UGC notification on "Regulation on Curbing the Menace of Ragging in Higher Educational Institutions, 2009", as IIS (deemed to be University), Jaipur has taken the following preventive measures to eliminate the scourge of ragging among the students and to provide them congenial environment to learn and develop both mentally and physically.

Objectives -

- To root out ragging in all its forms from the IIS (deemed to be University) by prohibiting and preventing its occurrence,
- To implement the provisions of UGC regulations on curbing the menace of ragging.
- To regulate and punish those who indulge in ragging, as provided under the UGC Regulation, 2009.

What constitutes Ragging?

Ragging constitutes one or more of any of the following acts:

- Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student;
- Indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student;
- Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a

sense of fear, shame, torment or embarrassment, so as to adversely affect the physique or psyche of such fresher or any other student;

- Act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher:
- Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students involved in ragging;
- Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
- Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student :
- Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student or students over any fresher or any other student.

Provision of Punishment at the Institution as recommended by the UGC

Depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee of the Institution, the possible punishments for those found guilty of ragging at the Institution level shall be any one or in any combination of the following.

- i. Cancellation of admission
- ii. Suspension from attending classes
- iii. Withholding/withdrawing scholarship/fellowship and other benefits
- iv. Debarring from appearing in any test/examination or other evaluation process Withholding results.
- vi. Debarring from representing the institution in any regional, national or International meet, tournament, youth festival, etc.
- vii. Suspension/expulsion from the hostel
- viii. Rustication from the institution for a period ranging from 1 to 4 semesters
- xi. Expulsion from the institution and consequent debarring from admission to any other institution.

Collective punishment when the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.

Anti Ragging & Grievance Cell Regulations

Do not be a victim or witness!!

Say No to Ragging!!

As per the UGC recommendations, Anti-Ragging Committee and Anti-Ragging Squad of IISU were constituted in 2009, which are still in existence and practice in soul and spirit of the Institution and following have been the measures taken to prevent any act of ragging in the University

(1) Constitution of Anti-Ragging Committee in the Institution

In order to ensure strict compliance and monitoring of Anti-Ragging measures as laid down in UGC Regulation, the Institution has constituted Anti-Ragging Committee by nominating the following representatives on it

At the helm of the Anti-Ragging Committee, there shall be the Head of the Institution. The Committee shall include the Registrar as a representative of Faculty Members; Deans; Representatives of Students; Parents and Non-Teaching Staff of the University.

The committee shall be meeting twice in a year to overview the effectiveness of the steps taken by the Institution to curb ragging and to make timely decision as and when required.

Functions of Anti-Ragging Committee

- It shall monitor the anti-ragging activities in the institution, consider the recommendations of Anti-Ragging Squad and take appropriate decisions.
- It shall be empowered to spell out suitable punishments to those found guilty,

(2) Constitution of Anti Ragging Squad -

The members of Anti-Ragging Squad shall be nominated by the Head of the Institution with such representation as considered necessary and shall consist of members belonging to the various sections of the campus community.

The Special Invitee shall comprise of faculty members with a coordinator appointed by the University.

Dr. Sitaram Pawar, Director, Department of Student welfare is currently the coordinator of the Anti-Ragging Special Invitee.

The functions of the Anti-Ragging Special Invitee -

- The Special Invitee comprises of a coordinator, nominated by the Vice Chancellor, who would be responsible for the effective implementation of the anti-ragging measures in the University. The coordinator will be supported by other teaching and non-teaching staff members from various faculties and sections of the University, nominated by the Vice Chancellor.
- The Special Invitee shall be responsible to vigil, oversight, and patrolling to ragging prone areas and considered hot spots. The members of the Special Invitee shall be empowered to inspect such places and arrange surprise visits to the hostel and other vulnerable areas.
- The Special Invitee shall be empowered to investigate incidents of ragging and make timely recommendations to the Anti-Ragging Committee.

(3) Affidavit by Student:

In order to ensure strict compliance and monitoring of anti-ragging measures and make students aware of the prohibition of ragging and the punishment, the University has prescribed, an affidavit to be signed by the student to the effect that he/she will not indulge in the act of ragging, and will be severely punished if found indulging in such activity, both under penal as well as under UGC Regulations and also affirm to the effect that he/she has not been expelled and/or debarred by any Institution and further confirms that he/she would not indulge, actively or passively, in the act or abet the act of ragging and if found guilty of ragging and/ or abating ragging, shall be liable to be proceeded under the regulations and / or under any Penal Law or any other Law for the time being in force. The University shall obtain the affidavit from students duly signed in by them, while seeking admission to the University in every academic year.

Apart from filling in the affidavit by the fresher's, the seniors will also sign in the undertaking, declaring that they shall not indulge in the ragging both in and outside the University premises.

(4) Affidavit by Parents:

In order to achieve the objective & as laid down in the UGC Regulations, for curbing the menace of ragging, the University shall obtain affidavit from

parents/guardians of students also, duly signed by the concerned parents/guardians of the applicant to the effect that he/she has read and understood the provisions of these regulations with same effect as laid down in the affidavit by students.

(5) Declaration of intent in the University prospectus and application form for admission

In view of drawing the attention of the prospective students seeking admission in the University and with regard to any Law concerning ragging and its consequences, the University shall declare its intent in the prospectus, brochure and instruction booklets for candidates in every academic year (both in English and Hindi). The University shall prescribe a form to be filled up and signed by the candidate to the effect that he/she is aware of the law regarding prohibition of ragging as well as the punishments. While the students registering for their admission are informed that ragging is totally prohibited in the University, and /or abetting ragging, is liable to be punished in accordance with the laid regulations as well as under the provisions of any penal Law for the time being in force.

(6) Meetings by Chairperson with various Anti-Ragging Committee members:

For curbing the menace of ragging, the Chairperson of the Anti-Ragging Committee, shall be conducting meetings, in addition to the regular meetings of the committee, with various members of the committee, such as Hostel Wardens, representatives of students, parents/ guardians, faculty members, non academic staff, in the beginning of every session to discuss the measures to be taken to prevent ragging in the University and steps to be taken to identify those indulging or abetting ragging and punish them suitably.

(7) Database for anti-ragging web-portal

The University shall upload all the information related to Anti-Ragging Committee, Anti Ragging Squad and any such information regarding ragging, on the University website.

(8) Display of names and contact numbers of members of Anti Ragging Squad:-

The names and contact numbers of Members of the Anti Ragging Squad shall be uploaded on the University website and displayed at various visible points, also at the entry passage which is conspicuous to all students. The members of anti-ragging squad shall be deployed at all vulnerable areas to monitor any activity which calls on for ragging

(9) Complaint Redressal Procedure

In order to deal with the complaints against ragging and help students in distress, the UGC has introduced National Anti-ragging helpline 1800-180-5522 (24 x 7 Toll Free). The grievances related to ragging can also be registered through email at helpline @antiragging.in for bringing the matter to public attention.

For any further information regarding ragging, the students can visit the UGC website i.e. www.ugc.ac.in and www.antiragging.in or can also contact UGC Monitoring Agency i.e Aman Satya Kachroo Trust on following No. 09871170303, 09818400116. (only in case of emergency).

(10) Anti Ragging Sensitization Programmes.

Guest Lecture on Anti Ragging Measures:- One or more Guest Lectures shall be organized to sensitize the students against the Ragging, motivating them to refrain from such activities and inform about members of Anti-Ragging Committee and Anti-Ragging Squad.

Following are the additional activities to be taken up by the University to curb the menace of ragging-

Guest Lecture on 'Eve-Teasing:

Guest Lecture on Eve-Teasing shall be organized to avoid such incidences from the campus and provide good atmosphere on the University campus.

Nukkad Natak- With activities like Nukkad Natak, community at large and students in particular shall be made aware of dehumanizing effects of ragging.

Posters and Warning Signs- Big posters on anti-ragging shall be placed at all prominent places and Notice Boards

Orientation session - The University shall organize orientation session for the new comers to apprise them that ragging in all its forms is totally banned in the entire campus or outside and in all means of transportation of students, whether public or private.

Regular Psychological Counseling for students - The University has a counseling cell for the students and will arrange the sessions for freshers as well as jointly with seniors, which shall be regularly done initially for three months from the start of the new academic session, to orient young minds with positive energy and refrain from the act of ragging.

Organizing activities. Apart from placing posters of anti-ragging at various places, workshops, picture and poster making activities will also be arranged to disseminate the message of antiragging.

Complaint Box- For registering complaints against ragging or other grievances, a Complaint Box shall be placed at prominent areas of the University where any student can write and drop his/her complaint or can give any suggestion regarding ragging, if any.

The Complaint Boxes shall be locked and can be accessed by the Nodal Officer of the AntiRagging Squad, once in a week. In case the Nodal Officer is not present on the campus, then a person nominated by the nodal officer shall be permitted to open the complaint box, the report of which shall be submitted by him/her to the Anti-Ragging Committee.

Upon getting any grievance related to ragging, the nodal officer shall be empowered to investigate the case and report the same to the Anti-Ragging Committee, which shall be further dealt strictly, as per the UGC Regulations.

CCTV - The University shall take steps to install CCTV cameras at all identified vital and vulnerable points to track and avoid incidents of ragging. To support further, in case of any complaint, the recording shall be kept safe for every session and can only be accessed by the nodal officer or anybody appointed by the Committee, for that purpose.

11) Online Anti-Ragging Feedback Mechanism- The University shall be collecting online feedbacks from the freshers during July to September, so that the students could be given a fair platform to register their complaints against ragging. The feedback report shall be submitted to the Anti-Ragging Committee for further analysis of complaints found, (if any) and taking appropriate action against those found guilty as per the UGC Regulation.

Sub: Anti-Ragging Measures to be initiated by all Karnatak University-Regarding

Ref:

- 1) The Directions of the Hon'ble Supreme Court of India issued in February and May, 2009
- 2) UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009 Under Section 26 (1)(g) of the University Grants Commission Act, 1956) F.1-16/2007(CPP-11). Dated 17th June, 2009.

As you are aware, ragging in educational institutions has become a menace in recent years. The Regulators of higher education like the UGC and the AICTE have also acted promptly by making the necessary Rules and Regulations to curb the menace of ragging in all the educational institutions.

Karnatak University has formulated an anti-Ragging Policy in accordance with the above Act, Directions and Guidelines to ensure that ragging is rooted out in all the educational institutions including the campus, constituent and affiliated colleges. The necessary information for initiating and institutionalizing the Anti-ragging measures in your college is contained in the booklet enclosed and circulated among all the educational institutions. You are hereby requested to initiate the following measures to make your college a ragging free zone.

- a) Constitute Anti-Ragging Committee (ARC), Anti Ragging Squads (ARS), and Mentoring and counseling Cells (MC) in your College as per the guidelines enclosed
- b) Send a letter to parents/guardians of the all students explaining the adverse effect of ragging and the Anti-Ragging Measures initiated by your institution

- c) Conduct Joint Sensitization Programmes (JSP) and Counseling of Fresher's and seniors by a Professional Counselor during the first two weeks of the academic year
- d) Conduct similar Programmes in the Hostels attached your college
- e) Conduct cultural, Sports and other activities involving both the junior and senior students
- f) Give wide publicity to prevention, prohibition and punishment in respect of ragging
- g) Conduct induction programmes for the fresher's only during the first two weeks of the proforma enclosed; and
- h) Take affidavits and undertakings from students, parents and Staff members in the p. enclosed, and
- i) Give Feedback regarding the Anti-Ragging Measures initiated in your college, incide ragging if any in your college and the action taken by the institution in the prescribed profor weekly during the first three months of the academic year And every month thereafter.

Please note that under Regulation 9.2 of the UGC Regulations mentioned supra

Where an institution, being constituent of, affiliated to or recognized by c University. fails to comply with any of the provisions of these Regulations or fails to curb ragging effectively, such University may take any one or more of the following actions, namely:

I Withdrawal of affiliation/recognition or other privileges conferred.

II. Prohibiting such institution from presenting any student or students the undergoing any programme of study therein for the award of an degree/diploma of the University. Provided that where an institution prohibited from presenting its student or students, the Commission shall mak suitable arrangements for the other students so as to ensure that suc students are able to pursue their academic studies

III. Withholding grants allocated to it by the university, if any!

IV. Withholding any grants chanellised through the university to the institutio

V. Any other appropriate penalty within the powers of the university

You are therefore requested to take all the measures necessary to cu the menace of ragging promptly, scrupulously and effectively.
