Resolution: The BOS Members suggested that the CBCS System in UG may be consider for implementation. Before implementation of CBCS in UG Level, the UG Teachers are advised to conduct a Workshop for CBCS System. Then the Special BOS Meeting will be conducted.

Item No.2: **Regarding changing the Syllabus of OEC Persian Knowing in III Semester.**

Resolution: The Board has approved and resolved, & strongly recommended that the Syllabus of OEC Pesian for Knowing in III Semester has to be changed. (the existing Syllabus enclosed) and the hard & soft copy of the Revised Syllabus is enclosed herewith.

The existing division of Marks for OEC Persian Knowing in III Semester is out of 100 Marks, 50 Marks for Theory, 25 Marks for IA and 25 Marks for Oral.

The Board has discussed and resolved to recommend that the division of Marks for OEC Persian for Knowing in III Semester, (50 Marks for Theory and 25 Marks for Oral shall be clubbed together as 75 Marks for Theory) and 25 Marks for IA, total 100 Marks. And Oral Test of 25 Marks is to be deleted.

Item No.3: Regarding to Separate the Board of Studies of UG & PG in Urdu & Persian.

Resolution: The Board has resolved & strongly recommended that in future it is better to made Separate Board for UG & PG to conduct the BOS Meeting smoothly. And in UG Board apart from the Chairman, One Internal and One External PG Member must be included with UG Members.
