Item No.1: Review of question papers of LL.M Examination held in May-June 2019

Res. No.1: The Board reviewed the question papers of LL.M Examination held in May-June 2019 and found the same to be in order and resolved to approve the same.

Item No.2: Revision of Panel of Examiners for 2019-20

Res. No.2: The Board reviewed the Panel of Examiners in Law (P.G) for the year 2019-20 and resolved to delete the teachers who have been duly retired from the University Services. Further the Board resolved to delete the names of Examiners working in Private Law Colleges and teaching in P.G. Courses there under.

Item No. 3. Re-Introduction of Two years LL.M (Full Time) Programme

Res. No.3: The Board resolved to Re-Introduce of the Two years LL.M (Full Time) Programme strictly from the Academic Year 2020-21 with two specialization courses namely, (i) Constitutional Law; and (ii) Corporate Law by doing away the One Year LL.M Course presently existing in the Department. This is necessary to maintain better standards in Masters Degree in Law and also for the purpose of uniformity in the State as well in the Country. Further it is resolved that the Regulations governing the Two Years CBCS LL.M Programme to be revised in tune with the adequacy and relevancy.

Item No. 4: Implementation of Bio-Diversity in the Curriculum

Res. No. 4: The Board examined the matter and resolved that much of this content is already included in the subject of Intellectual Property Rights (IPR). Hence, there is no need to consider this as a separate content in the curriculum.

Item No. 5. Implementation of the Braille Centre
