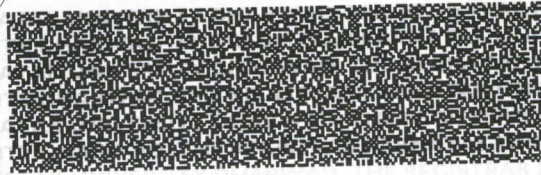

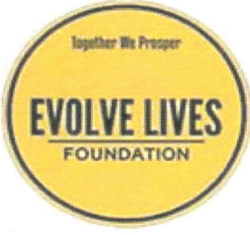

This Memorandum of Understanding (MoU) is made on 03rd day of April of the year 2023 between Karnatak University having its head office at Karnatak University, Pavate Nagar, Dharwad, Karnataka - 580003, India, (hereinafter referred to as Karnatak University) which expression shall, unless repugnant to the context or meaning thereof, include its successors, executors and administrators in office, legal representatives and permitted assigns on the FIRST PARTY

AND

Evolve Lives Foundation having its principal office at 'Arul – Kamal' building, 1st main, 10th - 11th cross, Nirmal Nagar, Dharwad: 580003, now represented by its Executive Director Mrs. Otilie Anban, which expression shall, where the context so admits, be deemed to include its successors, executors, and administrators of the SECOND PARTY.

Whereas Karnatak University was established in 1949 having 54 PG departments, 5 Constituent colleges and about 276 affiliated colleges, offering UG, PG and Ph.D. programmes along with diploma and certificate programs. About 1,10,000 students are studying in the year and 30,000 students are graduating every year.

The University is part of the UGC-INFONET which affords access to more than 5000 electronic journals for advanced study and research. It is NAAC accredited with 'A' grade.

Whereas Evolve Lives Foundation is a Public Charitable Trust formed under Indian Trust Act 1882. It was registered on 14/03/2011 with the registration number DWR-4-00188-2010-11. The Trust has been operating throughout India for its objectives which focuses on education, health, environment, entrepreneurship, employment, empowering of women, children, rural, urban, marginalized and downtrodden sections of society, civic participation for nation building in collaboration with public and private sector.

Cross pollinate with other regional, national and international partners.


Confidentiality of intellectual property which will be owned by the contributor or per KUD guidelines and policies.


Deployment of programs per the KUD guidelines.

Article #4

Partner will be operating as an individual entity and will not be held liable for the security or legal protocols governing KUD.

Safety, health, hygiene and security requirements of the students is a responsibility of KUD.

Both the parties under this MOU have the right to amend the rules that govern the incubation facilities provided, from time to time after consulting with each other before any information derived from cooperation activities under this MOU .

Any assets leased/kept by Partner at the location which need to be moved to a different location will be done under the supervision of Partner team member(s).
