This MoU is made and entered into this **9th June 2023** by and between Karnatak University, Pavate Nagar, Dharwad- 580003, Karnataka, India represented by The Registrar, herein after referred to as the **First Party**(KUD),

and

Federation of Pharma Entrepreneur, (M.P. Chapter) 104, Shrinath Niketan, 29, Snehataganj, Indore-452003, India, represented by The Chairman here in after referred to as the **Second Party** (FOPE).


KUD and the FOPE (M.P. Chapter) are together referred to as the "Parties" and singly as "Party".

Background:

The Bombay legislature of the erstwhile Bombay Presidency established Karnatak University through the Karnatak University Act 1949. It became a statutory University on 1st March 1950. The jurisdiction of the University covers Dharwad, Gadag and Uttar Kannada districts. It has several Post Graduate centres. The University (888 acres) is offering courses in the faculties of Arts, Commerce, Education, Law, Management, Science and Technology and Social Sciences. Symbolic of the University's vision and mission the emblem of the University consists of pipal tree at the centre, an open book. Figures of a bull, a rising sun and the legend '**Arive Guru**' i.e., Wisdom is Guru, implying that both wisdom and knowledge should be all pervading like the ramifying pipal tree and light up the world with knowledge and eradicate illiteracy. There are 51 P.G. Departments, 154 teachers and 4500 students (P.G., M.Phil., Ph.D.).

Federation of Pharma Entrepreneur, (M.P. Chapter) is the leading and largest Nonprofit Making and National Professional technocrats' body having more than 3000 members of various Pharma hubs in the country. It has more than 8 decades of service to industry. They provide guidance and services to various kinds of industry. They organize several national and international Pharma conferences, seminars.

The Registrar of Karnatak University, Dharwad and the Chairman of the Federation of Pharma Entrepreneur, (M.P. Chapter) have arrived at an agreement for mutual co-operation in Research, Training, Placement facilities, Extension activities and sharing of all academic resources between two institutions. Hence, this Memorandum of Understanding.

Article: I

The Terms of Agreement are as follows:

1. Prepare joint research projects, which are mutually beneficial for funding by various agencies/Institutions in India and abroad.
2. Allow experts of both the institutions to deliver sessions and joint consultations in research, prepare project proposals, extension activities etc for the benefit of society in large on mutually agreeable terms.
3. Jointly work on developing new subjects, inclusive of new technologies, content development for academia on mutually agreeable terms.
4. Jointly organize, host and participate Management Development Programs, Seminars, and Conferences on mutually agreeable terms.
5. Organizing and conducting Joint certification programs on mutually agreeable terms.
6. Collaborative work on research and publication of both student and faculty of both the parties.
7. Make available the facilities like library, research tools including USIC Lab etc to the members of both the parties,

8. Organizing of marketing fest, exhibition etc for different products in the both the parties places/ states.

Article: II

- The MOU between both the parties may be supplemented by detailed work plans to be developed jointly which describe more specifically the activities to be carried out under this collaborative program.
- Any Outcome of the Research in terms of Publications, funding, copyrights, patents and IPR can be shared based on the effort shall be used either or both the parties with due recognition of each parties contribution.
- If a need arises, KUD and the FOPE may constitute a **Coordinating committee/ Managing council** (Annexure) to work out the practical problems of collaboration if any, between the two institutions in general and to ensure proper and effective implementation of this MOU.
- The benefits accrued or arising from this collaborative effort may be used by either or both the parties with due recognition of each parties contribution.

Article: III

This agreement shall be in effect initially for a period of Five Years from the date on which this MOU is signed by both the parties and may be renewed thereafter, if mutually agreed. Either party may terminate the agreement by written notification sent to the proper officer of the institution; such notice must be received by either party, in Two months prior to the effective termination date. The agreement shall be subject to the Jurisdiction of the courts of Dharwad.

Composition of the Coordinating Committee / Managing Council

The Coordinating Committee /Managing Council shall consist of the following members.

- The Vice-Chancellor Chairman
 - The Chairman, FOPE (M.P. Chapter) Member
 - The Registrar, KUD Member
 - One nominee from Vice-Chancellor and two nominees from FOPE (M.P. Chapter) shall be the members of committee/ Council.
 - Nominee of the Vice- Chancellor acts as member –Convener.
- i. Any casual vacancy of nominated members caused by death, resignation, or the member ceasing to hold a particular office or a particular designation by virtue of which he became a member shall be filled up the Vice-chancellor for the unexpired term of office of the member.
 - ii. The Managing Council shall meet least once in an academic year to review the implementation of program and to assess the activities of the program.
 - iii. The Vice-Chancellor or, in his absence, any member nominated by him, shall preside over the meeting.
