Diploma in Police Science

This memorandum of understanding made on **29th September**, **2023** between Police Training School, Girinagar, Dharwad, Karnataka, India (herein after referred to as PTS) and Karnatak University, Dharwad, Karnataka, India (hereinafter referred to as KUD) witnesses as follows:

The Principal of Police Training School, Girinagar, Dharwad – 580002, Karnataka, India and

The Registrar, Karnatak University, Pavate Nagar, Dharwad - 580001, Karnataka

(Who for the purpose of this MoU are herein after individually referred to as 'Party and collectively referred to as the 'Parties').

Police Training school Dharwad is one of the 12 police Training Schools of Karnataka established in 2015

- WHEREAS, Police Training school (PTS) Dharwad is one of the 12 police Training Schools of Karnataka established in 2015. PTS is a premier Training School for training newly appointed Constables in the Karnataka state (hereinafter referred to as PTS Trainees).
- WHEREAS, KUD is a University established under Sec. 3 of the UGC Act 1956 Karnataka State University Act, 2000 running AICTE and UGC approved Programme through the affiliated institutions.
- In view of the above background, both the parties do hereby agree to establish collaboration according to terms and conditions set out in the articles enumerated in succeeding paragraphs.

4. Article 1 - Field of Cooperation

Co-operation between the two institutions is mutually agreed upon to be established in the field of Police Science award of **Diploma** in Police Science to 12th Pass for Police Constable trainees undergoing training at PTS.

On condition of completion of 03 months assignment submission after on job training to both the parties.

5. Article 2: Co-ordination of Programme

The collaborative programme between PTS and KUD shall be coordinated by a Coordinating Committee / Managing Council jointly agreed (Annexure) upon and ratified by the Principal, Police Training School, Girinagar, Dharwad and Registrar, Karnatak University, Dharwad. It is jointly agreed that:

- a) Syllabi for Diploma in Police Science shall be prepared by ad-hoc BoS Chaired by PTS having at least two representative of KUD.
- b) Diploma in Police Science course would be conducted at PTS and its other centers at Karnataka State level.
- c) Setting of question papers and conduct of examination for the Diploma will be carried out at PTS under the supervision of a representative of KUD.
- d) Evaluation and compilation will be carried out at Police Training School, Dharwad in the presence of Representative of KUD and Forwarded to KUD for preparation and Award of certificate to the trainees.
- e) Certificate would be conferred by KUD at PTS.

6. Article 3 : Mutual Cooperation between the organizations

- a) To jointly conduct and develop/organize short term online/offline training programs, seminars, conferences, workshops in the areas of mutual interest and in association with National and International Academic/Industry Partners.
- b) To share resources and expertise, human, technical and material in order to conduct programs as above to develop the education and training capability, including access to library resources and publications.
- c) To facilitate faculties and students of the Departments of Criminology & Forensic science, Law, Psychology, Journalism & Mass communication, for the subject matters, exchange, scholarship programs etc..
- d) To undertake research projects by KUD Teachers in the field of mutual interest.

7. Article 4 : Effective date and Duration of MoU

- a) This MoU shall be effective from the date of its approval by the competent authorities of Both Institutions.
- b) During its tenancy, the MoU may be terminated by prior notice of not less than 06 months by either party. However, termination of MoU will not in any manner effect interest of trainees who have been admitted to pursue of programme under the ambit of MoU.

c) Any clause or article this may be Modified or amended by mutual agreement in writing of PTS and KUD.

8. Article 5: Confidentiality

- a) By value of this MoU, both PTS and KUD will maintain strict confidentially and prevent disclosure of all information and data exchange under the scope of this MoU for any purpose other than in accordance with this MoU.
- b) Both PTS and KUD shall bind their respective personnel who come into possession or knowledge of any confidential information not to disclose the same to third parties without written approval of disclosing party or use such confidential Information for any use other than those intended under this agreement.
- c) Further, both PTS and KUD shall put in place adequate and reasonable measures to keep and store confidential information secure so as to prevent any unauthorized use.

9. Article 6: General Provisions

- a) The two institutions will carry out Educational activities, as a follow up to this Memorandum of Understanding. The activities must be carried out in accordance with appropriate laws and regulations existing in PTS and KUD.
- b) PTS shall provide entire infrastructure facilities including classrooms, laboratories, equipments, analytical tools and aids, library and qualified staff for running the Certificate course. Also, facilities for boarding and lodging of all trainees, counseling and guidance on Programme are to be done by the user institution.
- c) PTS shall get the Police Constable trainees enrolled to the Diploma and pay necessary affiliation application processing fees, affiliation fees, Deposit etc as per terms and conditions set by the Syndicate of KUD.
- d) However, other necessary fees like programme admission fees, examination fee, certification fee, eligibility fees(Wherever applicable) etc shall be paid by the trainees as per the prevailing fees of KUD, charging for the students of Regular UG Diploma programme.
- e) PST shall prepare study materials for the Diploma. The cost of production and distribution of study materials to police constable trainees will be borne by PTS.

10. Article 7: Amendments

- a) Any amendment and or addenda to the AGREEMENT shall be in writing and signed by the PARTIES hereto and shall only after execution be deemed to form part of the AGREEMENT and have the effect to modifying the AGREEMENT to the extent required by such amendment or addenda.
- b) IN WITNESS whereof this MoU has been executed by the duly authorized representatives of PTS and KUD here to on at PTS, Dharwad.

11. Article-8: Jurisdiction

Any matter dispute in this connection is under the Jurisdiction of Dharwad District.

Through this Memorandum of Understanding PTS and KUD affirm their commitment to fulfill and achieve the objectives mutually agreed upon.

Composition of the Coordinating Committee /Managing Council

The Coordinating Committee / Managing Council shall consist of the following members.

•	The Vice-Chancellor	Chairman
•	The Registrar	Member
•	The Registrar (Evaluation)	Member
•	The Director, PMEB	Member
•	Director CDC, KUD.	Member

- The Chairman, P.G. Department of Criminology and Forensic Science, Karnatak University shall be the Nodal Officer from Karnatak University.
- The Principal / Coordinator of the program nominated by the PTS shall be the Member-Secretary of the Council.
- Two Members nominated by the Vice-Chancellor in consultation with the concerned organization.
- Two Members of the concerned agency/institution/centre or other associated institutions nominated by the head of the institution/organization.
- Two representatives from the professional/bodies/related Government departments or the related organizations including international agencies, if necessary, nominated by the Vice-Chancellor in consultation with the Head of the Institution.

The total membership of the Coordinating Committee / Managing Council shall not exceed 15. If required, experts may be invited as Special Invitees, who shall have no voting rights.

- i. The term of the Managing Council shall be for five academic years.
- ii. Any casual vacancy of nominated members caused by death, resignation, or the member ceasing to hold a particular office or a particular designation by virtue of which he became a member shall be filled up the Vice-chancellor for the unexpired term of office of the member.
- iii. The Managing Council shall meet least once in three months in an academic year to review the implementation of program and to assess the activities of the program.
- iv. 50% of the Members shall form the quorum for the meeting. No quorum is required for an adjourned meeting.
- v. The Vice-Chancellor or, in his absence, any member nominated by him, shall preside over the meeting.
- vi. The agenda for the meeting will be made available to the members much in advance and it shall be discussed and debated before the decision is arrived at. If any issue involves voting, it shall be decided by a majority of votes; the Chairman shall have a casting vote in addition to his vote as a member, in case of tie.
- vii. Record of Meetings: Record of the business transactions of the Managing Council shall be maintained properly. Copy of the minutes of the meeting of the Managing Council shall be made available to the members and to the University.

Power and functions of Coordinating committee / Management council are similar to the statue of Karnatak University - recognition of certain institutions for specified studies / specialized studies and research statutes – 2023 under section 4.
