Whereas the Foundation, is the CSR Implementation Partner for M/S Expeditors International (India) Pvt. Ltd, Gurugram, hereinafter referred as Corporate Sponsor.

Whereas the Foundation has been taking up various infrastructure development projects like building computer; labs, construction of classrooms, providing free education to needy in schools, polytechnics, colleges and universities in various locations across India as part of CSR Program for Corporate sponsors.

Whereas the Foundation has successfully installed computer labs and 100-Seater Digital Library as requested by the First Party in December 2022.

Whereas the Foundation has entered into an MoU with Logistics Sector Skill Council (LSC), a Sec. 8 Company with registered address No 480A, 7th Floor, Khivraj Complex 2, Anna Salai, Chennai 600035.

Whereas the Foundation has now approached the first party for setting and facilitating training for jobless youth at college and universities dropout students particularly in the field of Logistics in association with First Party.

Whereas the request has been duly considered by the University Registrar and the Vice Chancellor of the Karnatak University.

NOW THEREFORE THIS MOU WITNESSETH AND IT IS HEREBY MUTUALLY ACCEPTED BY AND BETWEEN THE PARTIES AS FOLLOWS:

- 1. The first party will allocate a room in the campus or in any affiliated colleges to conduct various job-oriented training sessions.
- 2. The first party will provide access to the center for the students and facilitators between 8 AM 6 PM on all working days.
- 3. The foundation will be responsible for providing necessary training faculty, course materials and any other resources needed for such trainings.
- 4. Each cohort will be for a maximum batch size of 30 Only.
- 5. Identification of the candidates can be done jointly by the first party and the foundation.
- 6. Both parties will nominate a coordinator as a single point of contact for facilitating the programs.
- 7. Any costs for catering during the training period will be borne by the foundation.
- 8. There are no rents payable to the first party for utilizing the classrooms.
- 9. Equipment like a Projector, Screen etc. when required will be arranged by the foundation, if not available in the classrooms.

This Memorandum of Understanding will be valid for a period of 3 years. After reviewing the results of the partnership mutual consent, the MoU can be renewed for a further period of 5 years.

This MoU shall be executed in counterparts, each of which shall be an original and both of which taken together shall constitute the same MoU. This MoU can be modified only in writing and shall be effective when signed by both the parties.
