In the meeting of the Executive Committee held on October 13, 2012 it was resolved that a person shall not be eligible for more than one award /lecture in his lifetime. No one (except ISCA young scientist awardees) shall be given the second ISCA award under any circumstances.

It may please be noted that one person can nominate only one candidate for a particular Award.

*The Executive Committee in the Meeting held on October 15, 2019 resolved that for this Sectional award any life member of **Five years** of standing or continuous Annual Member of not less than **Five years** of standing as on July 31 each year and also with **Ten years** of teaching and research experience in University / College or as a scientist in Government recognized Laboratory / Institution can be nominated. It is also decided that the heads of the organizations which are providing funds to ISCA in any form cannot be nominated for consideration of any award.*

*It was also suggested that henceforth **no person can nominate in more than three ISCA Awards.***

*In the meeting of the Executive Committee held on 07.01.2019 it was resolved that while selecting the awardees for all ISCA Awards/ Lectures his / her **H index and Citation index** (in SCOPUS and Google Scholar) would be taken into account.*

*It will be very much appreciated if you would kindly send your nominations for each of the above awards as per proforma attached. **Four Copies** of completed nomination forms should reach this office latest by **July 31, 2022** in a sealed envelope with the name of the award written on the top.*
